## CONDITIONS OF HIRING

- The hiring is done at the week of Saturday 15 H at Saturday 10 H at the latest.  
Please take return to the reception the departure day before to make the inventory of fixtures.
  - The reservation will be effective only with reception of the deposit of 30%. The balance will be sent at the latest 1 month before your arrival. Any reservation is personal.
  - Cancellation:
    - + 30 days before the arrival, a sum of 55 € will be preserved.
    - - 30 days before the arrival, the deposit will be preserved.
    - Day before your arrival, totality will be preserved
- Any stopped stay because of the holiday maker or late arrival will not give place to any refunding.
- A security of 200 € is required on arrival. It will be restored the day of the departure or in the 7 following days subject to deteriorations or lacks. This security does not constitute a limit of responsibility.
  - Each locative is equipped with a living room of garden, of a refrigerator, material of kitchen, of a coffee machine, covers and pillows (except for linen of bed and toilet). It has 2 rooms (1 double bed + 2 small beds. For the mobil-home, there is in more WC and shower-room.
  - The material is the subject of an inventory. Each tenant is held the very same day to control it and inform the reception of possible anomalies.
  - The customer will have to return lodging rented in a very good state of cleanliness and hygiene. In the contrary case, expenses of cleaning will be retained with the 60 € height. Any lost object, broken or damaged during the stay will be invoiced.
  - Your animal must be walked outside the camp-site for its needs, and if it would be forgotten please clean. The animals are accepted in no public places attended by the holiday makers (medical - various buildings...). Their owners will have to provide themselves with their notebook of up to date vaccination. The supplement for the animals will be to regulate on the spot (25 € /week), and only one animal by locative.
  - The access to the camp-site is regulated. For this purpose a badge of entry is necessary. The barriers are closed of 23h at 7h morning. A carpark outside is at your disposal.
  - Each tenant is held to respect the rules of procedure of the camp-site under penalty of expulsion without refunding or allowance. A specimen of the rules of procedure is at your disposal with the reception.
